# Public Sector Bodies (Websites and Mobile Applications) (No.2) Accessibility Regulations 2018

The Regulations came into force on 23 September 2018 and implement the EU Directive on the accessibility of websites and mobile apps of public sector bodies.

The purpose is to improve the accessibility of public sector websites (including Parish Council sites) so that they can be used by as many people as possible – this builds on the existing obligations to disabled people under the Equality Act 2010 and the duty to make reasonable adjustments for disabled people.

# **Accessibility Statement for Blisworth Parish Council Website**

This website is run by Blisworth Parish Council.

We want as many people as possible to be able to use this website.

The website layout and text has been made as simple as possible to understand.

You should be able to:

- Change colours, contrast levels and fonts
- Zoom in up to 300% without the text spilling off the screen
